1. The Promoter

The promoter is: Moneybarn Limited of Athena House, Bedford Road, Petersfield, GU32 3LJ.

2. The competition

2.1 The title of the competition is: GRAND SLAM OF DARTS COMPETITION 2021 (see Clause 5 below for details of the Prize).

3. How to enter

3.1 The competition will run from 09:30 on Friday 5th November 2021 (the "**Opening Date**") to 09:00 on Monday 22nd November 2021 (the "**Closing Date**") inclusive.

3.2 All competition entries must be received by the Promoter at Athena House, Bedford Road, Petersfield GU32 3LJ by no later than 09:00 on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.

3.3 To enter the competition:

- (a) Complete and submit an entry form on our competition website at www.moneybarn.com/competition, by the Closing Date.
- (b) Complete and submit an entry to the question field in order to enter for a bonus prize at www.moneybarn.com/competition, by the Closing Date.

3.4 No purchase is necessary and there is no charge to register for use of the website.

3.5 The Promoter will **not** accept:

- (a) responsibility for competition entries that are lost or delayed in transit, regardless of cause, including, for example, as a result of equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
- (b) proof of transmission as proof of receipt of entry to the competition.

3.6 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

3.9 The competition entries will be picked at random by one of the Moneybarn Marketing Team. Once winners have been selected, the decision will be final.

4. Eligibility

4.1 The competition is only open to residents in the UK aged 18 years or over, **except:**

- (a) employees of the Promoter or its holding or subsidiary companies, this includes being taken as a guest; or
- (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the competition or its administration.

4.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize **OR** any prize you may win. The Promoter may require you to provide proof that you are eligible to enter the competition.

4.3 The Promoter will not accept competition entries that are:

- (a) automatically generated by computer;
- (b) completed by third parties or in bulk; or
- (c) incomplete.

4.4 There is a limit of one entry per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.

4.5 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.

4.6 Competition entries cannot be returned.

5. The Prize

5.1 A shirt signed by the winner of the Grand Slam of Darts. There will also be a runner up prize of a dartboard signed by top PDC stars.

5.2 Prizes are subject to availability. There is no cash alternative for the prize.

5.3 The prize is supplied by Professional Darts Corporation, Mascalls, Mascalls Lane, Brentwood, Essex, CM14 5LJ (the "**Supplier**"). The Promoter reserves the right to

replace the prize with an alternative prize of equal or higher value if circumstances beyond the Promoter's control makes it necessary to do so.

- 5.4 The prize is not negotiable or transferable.
- 5.5 In order to claim the prize, you must complete the application form with a correct email address, telephone number and postcode, to allow the Promotor to contact you with information on how to claim your prize, if you win.

6. Winners

- 6.1 The decision of the Promoter is final, and no correspondence or discussion will be entered into.
- 6.2 The Promoter will contact the winner personally as soon as possible after the Announcement Date, using the email address or telephone number provided with the competition entry. The Promoter will not amend any contact information once the competition entry form has been submitted.
- 6.3 The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation the Promoter will publish the full name and County of all prize winners and, if applicable, their winning entries on their social media platforms and website on the day that entrants are notified of their successful entry. This day will be Monday 22 November 2021 (the "**Announcement Date**").
- 6.4 If you object to your full name, County and winning entry being published or made available, please contact the Promoter by sending an email to marketing@moneybarn.com. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.

7. Claiming the prize

- 7.1 Please allow twenty working days for delivery of the prize. If you do not reply to the promoter's correspondence by Thursday 25th November 2021 to claim your prize, your claim will become invalid.
- 7.2 The prize may not be claimed by a third party on your behalf.
- 7.3 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available or has not claimed their prize within three days of the Announcement Date, the Promoter reserves the right to offer the prize to the next eligible entrant selected from the valid entries that were received before the Closing Date.

7.4 The Promoter does not accept any responsibility if you are not able to take up the prize.

8. Limitation of liability

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

9. Ownership of competition entries and intellectual property rights

9.1 The Promoter does not claim any rights of ownership in your competition entry.

9.2 You agree that the Promoter may, but is not required to, make your entry available on its website www.moneybarn.com and any other media, whether now known or invented in the future, and in connection with any publicity of the competition.

10. Data protection and publicity

11. General

11.1 If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter may, at its sole discretion, reserve the right to exclude you from participating in the competition.

11.2 The Promoter reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so.

11.3 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
