1. The Promoter

The promoter is: Moneybarn Limited of Athena House, Bedford Road, Petersfield, GU32 3LJ.

2. The competition

2.1 The title of the competition is: WORLD DARTS CHAMPIONSHIP COMPETITION 2023 (see Clause 5 below for details of the Prize).

3. How to enter

- 3.1 The competition will run from 09:30 on Friday 27th January 2023 (the **"Opening Date**") to 09:30 on Monday 11th December 2023 (the **"Closing Date**") inclusive.

4. Eligibility
