

Terms & Conditions – British Superbike Championship Competition 2024

1 The Promoter

1.1 This prize draw is operated by Moneybarn Limited incorporated and registered in England and Wales with company number 02766324 whose registered office is at Athena House, Bedford Road, Petersfield, GU32 2LJ ("Moneybarn").

2 The Promotion

2.1 The prize draw forms part of the British Superbike Championship Competition 2024.

3 Promotion Period

- 3.1 The prize draw will run from 10:00am on 11th April 2024 (the "**Start Date**") to 11:00am on 27th September 2024 (the "**End Date**").
- 3.2 Entries received by Moneybarn before the Start Date or after the End Date set out in condition 3.1 will be void and will not be entered into this prize draw.
